MDAFP TERMS AND CONDITIONS

Application Process:

Please note this is an application process. You will be advised of your selection as a sponsor within 30 days of application submission. Payment will not be processed until sponsor is notified.

Contract:

The Terms and Conditions become binding upon acceptance of this contract between the applicant, inclusive of employees and agents, and the Maryland Academy of Family Physicians (MDAFP). Payment in full is required by January 12, 2024. If payment is not received by this date, your partnership agreement will be terminated, and company information and logo will not be displayed.

Confirmation/Exhibitor Profile:

Contact <u>Madeline Everson</u> if you have not received a confirmation of your received application form within 10 business days of submission. Exhibit profile will be assigned based on sponsorship priority and thereafter on a first-paid basis. Exhibit profile is assigned upon receipt of application and payment in full. MDAFP reserves the right to reject any application.

Cancellation Policy:

Cancellation must be received in writing to Madeline Everson at madeline@mdafp.org. Partner will receive partial refund based on the structure outlined below:

- 75% refund of total cost of sponsorship if cancelled from date of contract signing to 60 days before the event (on or before December 26).
- 50% refund of total cost of sponsorship if canceled from 31-59 days before the event (December 27-January 24).

*If written cancellation notice is received less than 30 or fewer days prior to the event start date (on or after January 25), partner forfeits 100% of total cost for sponsorship. MDAFP shall not be liable for any damages or expenses incurred by Sponsors or Exhibitors in the event the conference is delayed, interrupted, or not held as scheduled.
