

On February 1, 30 MDAFP members were in person for Family Medicine Advocacy Day where they visited the MD State House to take part in the legislative process. They gained insight into pressing legislative issues, took in helpful advocacy tips, learned how to convey their medical expertise, and met with legislators to advocate for family physicians.

# **EDUCATION & PATHWAYS**

- MDAFP offered our members a variety of educational opportunities with over 37 AAFP Prescribed Credits. This included a combination of inperson and virtual sessions to help our members meet the ABFM board certification requirements and more.
- Pre-National Conference Dinner
  - MDAFP hosted a networking dinner for students and residents on Sunday, June 2. 18 students and residents attended and learned about resolution writing, leadership opportunities, and how they could make the most of their time at AAFP's National Conference.

Several grants were awarded to develop opportunities to provide our members learning and engagement to incorporate into their practices and ready our future workforce.

- GRAIL provided MDAFP with a \$2,000 unrestricted grant for education. These funds are allocated to this year's Annual Meeting & Winter Refresher.
- ABFM awarded MDAFP \$10,000 to fund our Chapter Pilot Program for a project that aligns with ABFM's Strategic Plan: 2019-2025. Our Public Health Workgroup initiated this idea through their work on a toolkit and education to help our members to become informed about the importance, value, and movement toward integrating primary care with public health. A team of FM Residents interested in public health completed this project and established a collaboration with MACHO.
- ABFM also awarded our chapter \$5,000 as a recipient of the Family Medicine Residency Learning Community Planning Grant. We are now working with Maryland, DC, and West Virginia family medicine residencies to develop ideas for an impactful residency learning network that enhances family medicine residency programs, training experiences for residents and ultimately, the improvement of patient care in our communities. Completion of the planning grant resulted in a second opportunity to receive \$75,000 in funding for the purpose of the Seed Program Grant which is to develop, create, and expand sustainable infrastructure for learning networks/collaboratives that invite residency leaders, teaching practice medical directors, faculty and residency coordinators to intentionally share and adopt improvements and innovations in GME. We were awarded this grant, too. The education and other phases of this grant will be carried out in 2025-2026.


